

## Competition Terms and Conditions

<b>Conditions of Entry – ‘Cooped Up at Home’ Facebook Competition</b>
1.Information on prizes and how to enter form part of these conditions of entry.

3.Entry is open to current Victorian citizens. Entrants must be 18 years and over to enter the competition.
4.The competition commences at 9am Eastern Standard Time (EST) on Wednesday 8th 2020 and closes at 5:00pm AEDT on Monday 11 <sup>th</sup> May 2020. Entries posted outside the competition dates will not be considered.
5.To enter the competition, entrants must upload a post showing how they are keeping children safe at home, to Kidsafe Victoria’s Facebook page.
6. For entries to be valid, the entrant must <ol style="list-style-type: none"><li>a) Post entry to Kidsafe Victoria’s Facebook page within the weekly competition entry and closing dates.</li><li>b) Be a Victorian resident</li></ol>

8.Individuals may enter as many times as they like into the competition.

11.The four weekly winning entries will receive a voucher of the value of \$100 each.
